Application for Discretionary Housing Payment (DHP)

To be entitled to a DHP, you must meet the following criteria:

- be receiving some HB or UC Housing Costs (minimum award of £0.50 per week)
- be able to demonstrate to us that you need further help with your housing costs. Housing costs generally mean rent but can cover rent in advance and rent deposits and other associated lump sum costs e.g. removal costs.
